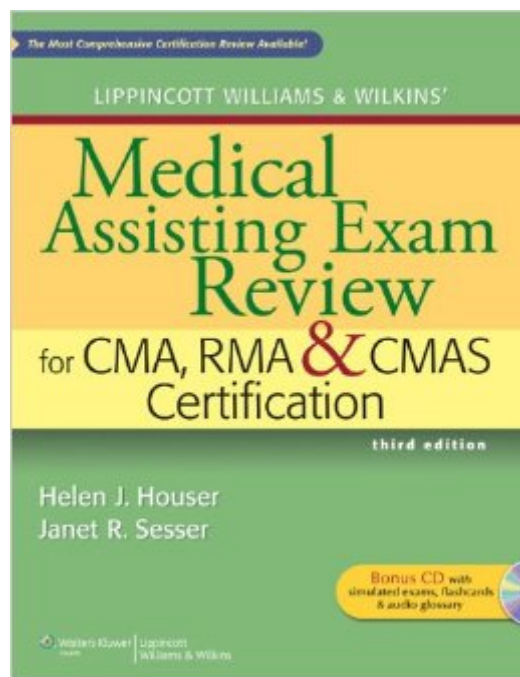

I live in the state of Washington and graduated from a nine month program in Seattle in 2010. My GPA was 3.87 when I graduated and I found work as a Medical Assistant right away so I didn't take the CMA certification test. Well, I finally got around to taking the test yesterday and passed after using this book (not my textbook from school) exclusively. It helped me tremendously in that I graduated 3 years ago and all the information in the book was pertinent to the test material, and most of the material in the book was included on the test. I especially liked the detailed study guides and practice tests you can take at the back of the book and after each chapter to quiz yourself and

to prepare for the real exam. I would say almost 99% of the questions asked on the test were covered in the book; there were several that I hadn't a clue what they were talking about but it's ok to guess on the test without being penalized so that's what I did. I studied less than 2 months due to work schedule, approximately 1 month in all and I utilized the suggestions in the book on how to study, how long and when.
